IN CASE OF EMERGENCY DURING THE NET, CALL BREAK-BREAK, YOUR CALL SIGN & STATE YOUR EMERGENCY TRAFFIC FOR NET CONTROL TO ASSIST YOU.

(ANY ANNOUNCEMENTS FROM THE NET CONTROL OPERATOR, PRIOR TO CALLING FOR CHECKINS)

WE WILL NOW BEGIN CHECKINS. STATIONS WILL BE CALLED ALPHABETICALLY BY THE FIRST LETTER OF THEIR CALLSIGN SUFFIX. WHEN CHECKING IN WITH NET CONTROL, PLEASE GIVE YOUR CALLSIGN PHONETICALLY, YOUR NAME, AND COUNTY OF OPERATION. IF YOU HAVE ANY TRAFFIC OR COMMENTS PLEASE LIST IT WITH THE NET CONTROL OPERATOR.

(AS STATIONS CHECK IN, ACKNOWLEDGE EACH ONE)

ARE THERE ANY SHORT TIME STATIONS OR MOBILE STATIONS, PLEASE CALL KF4UTJ NOW.

STATIONS ALPHA THRU MIKE, PLEASE CALL KF4UTJ AT THIS TIME.

STATIONS NOVEMBER THRU ZULU, PLEASE CALL KF4UTJ AT THIS TIME.

ONE LAST CALL, ALPHA THRU ZULU, PLEASE CALL KF4UTJ AT THIS TIME.
